ITEMS FOR BOARD ACTION:

Discuss amending law to allow horses in the Village:

Mayor Murphy reported on the research that he did. One horse needs at least 1 acre of open pasture and some sort of shelter. The board discussed various options that should or should not be included in an amendment if this proceeds. It was decided that a committee consisting of Deb Fisher and Dan Wakeman be formed to pursue drafting a possible amendment that the Board and the people of the Village of Dryden might be agreeable to.

The Green spaces will not be shared. The proposed date for grinding is Sept 18th and paving the next couple of days weather permitting. Paul Sabin Suggested putting a sign up to notify the residents.
