Dave Sprout – code enforcement- Dave emailed his report to the board, noted that there were some cars on Lee Rd. that he is looking into that may be unregistered. He was reminded of a house on Lake Road that needs investigating.

Ken Scherrieble-Camden Group:

December's average daily sewage flow is still slightly high. He presented three proposals to the Board regarding rebuilding the blowers. It is looking more promising to rebuild rather than replace. He will continue to work on these proposals and submit his recommendation at the next meeting. He has worked on a Capital Plan for the Sewage Treatment Plant and feels

the Board will be impressed. He will also present that at next month's meeting. There were some electric issues at the plant today, a battery charger failed and a replacement is needed. Everything else is working fine.

Bill Ackrod-Neptune Fire Co.

Bill Ackrod introduced himself and requested that the Board authorize the Mayor to sign the contract between The Town of Dryden and Neptune Hose Company for fire protection. At this time approximately 1/3 of fire calls are in the Village and 2/3 in the Town. The Town of Dryden has increased the amount they will pay for fire protection 20 percent. It was agreed that the Village Board and Neptune Fire Company would review their contract in February before the new budget was passed.

Waiver for Sergeant Lawrence- Sgt. Tagliavento explained this waiver was to allow retired Sgt. Lawrence to make over the salary cap of \$30,000.00 dollars if necessary. All Board members agreed for him to submit this.

Electrical Upgrade for Electric Charging Station – Mayor Murphy and Trustee Wakeman are looking into retractable vs self-winding, where the best location would be and are obtaining estimates for the installation. They are also looking at service providers. They should have more information at the next meeting.

Sexual Harassment Training- no report at this time, the state has final guidelines.

LED lighting for Street Lights- Mayor Murphy reports that the NY Power Authority is working on obtaining a County wide quote and state financing.

Discussion on parks/trails grant- Mayor Murphy and Trustee Fisher will be attending a training session on obtaining grants January 24, 2018. They are working on a grant that could pay \$5000.00 towards a pavilion for Montgomery Park

Montgomery Park Gazebo repairs – Paul Sabin has received two quotes, is waiting on a third. There difference in estimates was enormous. The Board briefly discussed the safety, the need for the gazebo, and removal verses rebuilding. This needs to be addressed further at the next meeting.
