Mayor Michael Murphy opened the Board meeting at 7:05 p.m. The Pledge of Allegiance was recited.

#### Privilege of the floor opened at 7:06 PM.

WWTP report: Camden Group: Ken Schribble presented his Monthly report for operations and management of the WWTP to date. He noted that we were right where we want to be at just over 500 thousand gallons per day average daily flow. He reported an issue with an inflow pumps station, the pump had to be pulled, it seized, he is getting a price for repair vs replacement. Everything else looks good and is running well.

Bob Beck on Rail Trail & Dryden involvement:

Bob Beck presented the new Rail Trail Logo and distributed a flyer with a proposed Dryden Rail Trail and suggested reading the Town of Dryden minutes as there is a lot of information on their website. He reported that they have a eleven member task force and is looking for new members and The Village of Dryden's help with such things as Kiosks, signs, maps, and parking areas.

### Water Project update:

Steven May reported: Restoration is 95 % complete on Lake Rd. Rochester and Marsh Streets are complete. Started well house 1 pump to TC3- Reservoir is offline, not empty, new tank almost full. Ferguson well house floor is poured, walls going up on schedule and should be operational by end of July or early August. He is waiting on a report to see if a drain is needed. All caps are finished but one. That one will be finished within a day. The Lee Rd reservoir is draining and will take a week to drain and then demo will begin.

Rich DeGuida reported the budget started at \$8.9 Million- the line items are now at aprox. \$7.0 million. The short term finances ends in November, long term at 0% interest should be between \$6.9 -\$7.0 million. He presented the board with 5 proposals from Moody and Associates. After much discussion it

was agreed that Rich DeGuida would get a new updated proposal and a special meeting would be called at a later date.

Upon no further comments, Privilege of the Floor was closed at 8:13 p.m.
