The pledge to Allegiance was recited and the Board meeting was opened at 7:01pm

Privilege of the Floor:

The floor was opened at 7:01pm

Paula Parker- Thanked the Board for allowing the painting of the Climbing wall, but while she was at the park noticed a problem with "dogs". There were many dogs in the park not on leashes and way more "poo" than should be in a public park. She did some pretty extensive research on this issue. She is hoping that the Board will do something to correct the situation whether by enacting a local law, signage, Poop stations or some sort of enforcement. She also suggested an out-side service "Doody Calls" in Syracuse (315)365-5618. The Board agreed there is a problem and will look into what can be done about the issue.

Rocco Lucente- Wanted to address the Board regarding concerns heard at the open house. In Phase one of the project the roads will be gravel until construction is complete to allow for the heavy equipment. They then will be blacktopped. The walking trails will be gravel- Attorney French suggested something other than gravel as strollers do not do well on gravel- Trustee Wakeman suggested stone dust. Rocco also wanted the Board to be aware that the Village Solar's in Ithaca only have 1.25 parking spaces per unit and do not seem to have any issues and they have more units per acre. Overall, he thought the open house went well. At this time the Board feels that he needs to submit his plan formally as per the local PDA law.

Don Schutt is with the Dryden Little League and he came to the Board proposing a new softball field on the property owned by Bruce Brecht that the Village is in the process of possibly swapping for a Village owned piece of land closer to Bruce's garage. He spent the next forty minutes going over his idea for this new softball field which would include a row of overgrown almost dead trees to be removed. The Town of Dryden can bring in the fill that would be needed and it could be seeded by October 1. The Board discussed but cannot do anything until the property is Village owned.

The Camera's are still not all installed and a date to be finished is not set. The Dryden Central School district wants to renew their contract for Police presence at football games. (Clerk/Treasure Marsh will have the contract prepared tomorrow.) This year the Chief would like to have first responder night to be on a Sunday afternoon instead of a Wednesday evening. The date in mind is September 24. He also has a NYS DOT Commercial truck detail scheduled for September 16th. Last but not least new recruit Ron Lower has completed his 160 hours and is doing well.
