## **Public Hearing:**

Open Public Hearing on Community Development Block Grant at 7:02p.m.

Dan Ellis from Thoma Development in Cortland introduced himself and briefly explained the process of the drafting a Community Development Block Grant. First a mailer was sent to the Village residents requesting income information to see if the Village had enough qualified home owners. At this time there is wait list of 38 eligible home owners, Dan would like to have at least 40 or 45. With 45 eligible candidates Thoma Development can apply for the full \$500,000.00 grant limit. Aprox. \$20,000 to \$30,000 can be used for each eligible home owner for substandard conditions. These conditions include but not limited to leaking roofs, non-operating windows, sagging or falling porches, foundation problems, insufficient insulation and old knob and tube electrical wiring. The eligible residents can choose their own contractors after obtaining at least 3 estimates. The Grant will only pay for the lowest estimated amount and the home owner will need to pay the difference if they choose a more expensive contractor. Should the resident not live in their home for 5 years they will be required to pay back a prorated amount of the grant money. The lowest income to the

greatest need will determine the order in which the grant money will be used. This answered Alan Macomber's questions. No other village residents were in attendance.

The Public Hearing was closed at 7:16 p.m.

#### **Privilege of the Floor:**

Privilege of the Floor was opened at 7:16p.m. The Mayor asked if there was anyone wishing to speak, there were none. Privilege of the Floor was closed at 7:16 pm'

#### **Monthly Reports:**

**Ken Scherrible** Average daily flows are .409 million gallons, the New A/C units are installed and running with no concerns, they are continuing with the flow monitoring. Ken has had some issues with his meters and if not resolved will be purchasing sonar meters that will do collect even more data. The new blower #1 that was installed is malfunctioning; Neuros has been working with Ken to try to figure out what the problem is. Trustee Wakeman asked if the floor vibration has ever been checked. Ken seemed to think that was well worth checking on. Everything else is running smoothly.

**Rich DeGuida-** Water System update, Tompkins County Health Dept. has cleared the way to back fill the Ferguson Road tank. No leak has been found and the Village has met all the requirements. DN Tanks will be doing site restoration at the TC3 tank. The health dept. brought to his attention the DCSD was putting in new water lines from the High School to the transportation facility and were using 8" pipe. For possible future development in the Village, 10" pipe would be beneficial in that area. Rich and the Mayor have met with the school to see if this is possible. The School will meet with their engineering firm and attorney to see if they can do a change order and what the costs to the Village would be. Rich will meet with the Village Board to discuss this at a later date.

- Pearl Harbor Day (December 7)
- Peace Officers Memorial Day (May 15)
- Patriot Day (September 11)

#### Village Guidelines:

Additional events when the flag could be lowered to half-staff to commemorate the death of a local serviceman, official, or public servant (including but not limited to service in the armed forces of the US, service in volunteer fire, ambulance, police or emergency medical services, or governmental service) who, in the opinion of the local agency concerned, contributed to the community, with approval of the Mayor or Deputy Mayor.

The flag should be lowered to half-staff on the day of the funeral and be raised back to full staff after one (1) day (or longer if deemed appropriate). The flag lowering is the responsibility of the Dryden Village PD.
