#### Termination of Water Service at building recently purchased by First National Bank of Dryden

Paul explained that terminating water service could mean pulling bricks and possibly tearing up the sidewalk for the winter. There could also be problems where water would need to be shut off to the entire block. Without removing some bricks he would not know if he could turn the service off without digging up the sidewalk. The Board was in agreement that they did not want to have the sidewalk torn up and left for the winter. Paul will report back on if he can turn the service off without removing the sidewalk.
