Introductions were made and Chairmen Curtis appointed David Cullen Bravo as acting member for this meeting.

New Business:

Solar law:

Chairman Curtis made sure all members had the latest version of the Solar Law draft, which he highlighted all purposed changes and pointed out questions for NYSERDA. The Board then reviewed each item and discussed concerns with Candace Rossi. Rossi explained that residential systems can only generate up to 25 kwh or 110% of the 12 previous months, this is regulated by the utilities. Panel's that are 7 sq. ft. can produce approximately 300 watts. The average residential system generates 6kw. New construction estimates come from a Licensed Engineer. Less than 1 % of a solar panel has hazardous material that can only be released by the heat of a chemical fire. Solar Energy Systems are not set up at this time to use when the electrical power is out. Rossi was able to address all concerns and answered all Board members questions. The Board has now completed their Solar Energy Law Draft and would like to present it to the Board of Trustees of the Village of Dryden and to the Public at a joint hearing on November 14, 2018 at 7 pm. The Board of Trustees has already set aside this time.
