The Pledge of Allegiance was recited, Mayor Murphy opened the Public Hearing at 7:02 regarding increasing the income limits to the Senior Real Property Tax Exemption. There was no one present who wished to be herd so the Public Hearing was closed at 7:02.

## **Rocco Lucente presentation:**

Rocco Lucente introduced himself and his architect Larry Fabbroni. They presented the Board with a slide show presentation and answered questions regarding their proposal to build a Planned Development Area on the previous Dedrick Farm site located on the north side of town boarding on Mott Rd and North Street behind the Dollar General Store. The slide presentation showed the different phases of development that are planned including buildings, parking areas, green spaces and roads. The Mayor sent a list of questions previous to the meeting. The answers to some of them are as follows; they plan on above ground utilities, buried is too expensive, they will abide by all planning and zoning local laws as well as the fire department regulations. They will confer with the tree committee on tree plantings, and have plans in place for sidewalks. They will look into EV charging stations, numbers of parking spaces per unit, and have a traffic study done to insure the best possible entrance and exit configurations. Their plan for the first year is 48 units on Mott St. They will present this to the entire planning Board on January 30, 2023

Mayor Murphy opened Privilege of the Floor at 8:18 p.m. and as there was no one wanting to address the Board he closed Privilege of the Floor at 8:18 p.m.

Camden Group- - The Board accepted the emailed report.

## **Supervisor's Reports:**

**DPW**-Caleb Bean reports that the DPW has been working on snow and ice removal when needed and when not they have been doing some trimming. They have removed all the Christmas decorations and helped move the Clerks office back downstairs. They have replaced a chlorine pump at the Lake Rd. Well house and repaired chlorine equipment at Dryden Lake Park. They did water readings and because of meter reading issues have been rereading and checking on meter problems. They have pretty much finished picking up Christmas trees.

**Police Dept.** – Chief Tagliavento handed out his report and added 2022 volume call comparison report for Groton, Cayuga Heights and Trumansburg. He informed the Board that they successfully moved the department back downstairs, all the camera equipment is in but Adirondack Cabling isn't in a hurry to install as it is now winter. He has been working with the Electrical Contractor on some of the installation of the old cameras. They have also decided that the" brains" of the new camera equipment will now be installed near the server freeing up room in the patrol room.

**Resolved,** that the Board of Trustees of the Village of Dryden hereby adopts Local Law No 001-2023 to Increase the Village of Dryden Real Property Senior Tax Exemption

#### LOCAL LAW 001 OF THE YEAR 2023

#### TO AMEND INCOME LIMITS FOR THE SENIOR CITIZENS' REAL PROPERTY PARTIAL TAX EXEMPTION LAW

Be it enacted by the Board of Trustees of the Village of Dryden as follows:

SECTION I.

#### PURPOSE AND INTENT.

The State of New York has passed legislation (Bill No. A0956/S3085, Laws of 2022, Chapter 488) and the same was signed by the Governor on August 8,

2022 to increase the income limits for the Senior Citizens Exemption. As a result of that revision, the Village desires to update the income limits and schedule for Percentage of Assessed Valuation Exempt from Taxation set forth in Subsection 110202, Section 1102, Article II ("Senior Citizens' Tax Exemption") of the Village of Dryden Code, and the purpose of this local law is for the same.

#### SECTION II. AMENDMENTS.

A. Subsection 110202, Section 1102, Article II (entitled "Senior Citizens' Tax Exemption,") is hereby amended to read in its entirety as follows: **Subsection 110202.** 

Pursuant to the provisions of § 467 of the RPTL, real property located in the Village owned by one or more persons, each of whom is sixty-five (65) years of age or over, or real property owned by husband and wife or by sibling, one of whom is sixty-five (65) years of age or over, or real property owned by one or more persons, some of whom qualify under § 467 of the RPTL and others of whom qualify under § 459-c of the RPTL, shall be partially exempt from taxation by the Village for the applicable taxes specified in said § 467 of the RPTL based upon the income of the owner or combined incomes of the owners. A person otherwise qualifying for such exemption shall not be denied the exemption if such person becomes sixty-five (65) years of age after the appropriate tax status date and before December 31 of the same year. For the purpose of this resolution, the term "sibling" shall mean a brother or sister, whether related through half blood, whole blood or adoption. Such partial exemption shall be to the extent set forth in the following schedule:

Annual Income of Owner or Combined Annual	Percentage Assessed Valuation Income of Owners Exempt From Taxation
p to \$35,000.00	50%
More than \$35,000.00 but less than \$36,000.00	45%
36,000.00 or more, but less than $37,000.00$	40%
\$37,000.00 or more, but less than \$38,000.00	35%
\$38,000.00 or more, but less than \$38,900.00	30%
\$38,900.00 or more, but less than \$39,800.00	25%
\$39,800.00 or more, but less than \$40,700.00	20%
\$40,700.00 or more, but less than \$41,600.00	15%
\$41,600.00 or more, but less than \$42,500.00	10%
\$42,500.00 or more, but less than \$43,400.00	5%

B. Subsection 110207, Section 1102, Article II is hereby amended to read in its entirety as follows:

#### Subsection 110207.

This Section 1102 and the partial tax exemption provided for herein shall become effective immediately and shall apply to assessment rolls prepared on the basis of taxable status dates occurring on or after January 1, 2023.

#### SECTION III. SUPERCEDING EFFECT.

All local laws, resolutions, rules, regulations and other enactments of the Village of Dryden in conflict with the provisions of this local law are hereby superseded to the extent necessary to give this local law full force and effect.

#### SECTION IV. VALIDITY.

The invalidity of any provision of this local law shall not affect the validity of any other provision of this local law that can be given effect without such invalid provision.

#### SECTION V. <u>EFFECTIVE DATE</u>.

This Local Law shall be effective upon its filing in the office of the Secretary of State.

Set a Public Hearing for PROPOSED LOCAL LAW 002 OF THE YEAR 2023 A LOCAL LAW TO ALLOW THE OVERRIDE OF THE TAX LEVY LIMIT ESTABLISHED IN GENERAL MUNICIPAL LAW §3-C

#### SECTION I. PURPOSE & INTENT.

It is the purpose and intent of this local law to allow, if determined necessary and/or appropriate, for the Board of Trustees of the Village of Dryden to adopt a budget for the fiscal year commencing in 2022 that requires a real property tax levy in excess of the tax levy limit as defined by General Municipal Law §3-c.

## SECTION II. <u>AUTHORITY.</u>

This local law is adopted pursuant to subdivision 5 of General Municipal Law §3-c which expressly authorizes a local governing body to override the property tax cap for the coming fiscal year by the adoption of a local law approved by a vote of sixty percent (60%) or more of said governing body.

### SECTION III. TAX LEVY LIMIT OVERRIDE.

The Board of Trustees of the Village of Dryden, County of Tompkins, is hereby authorized, if determined necessary and/or appropriate, to adopt a budget for the fiscal year commencing in 2023 that requires a real property tax levy in excess of the amount otherwise prescribed in General Municipal Law §3-c.

#### SECTION IV. <u>SEVERABILITY.</u>

If a court determines that any clause, sentence, paragraph, subdivision or part of this local law or the application thereof to any person, firm, or corporation or circumstance is invalid or unconstitutional, the court order or judgment shall not affect impair or invalidate the remainder of this local law but shall be confined in its operation to the clause, sentence, paragraph, subdivision or part of this Local Law or in its application to the person, individual, firm, corporation or circumstance directly

involved in the controversy in which such judgment or order shall be rendered.

#### SECTION V. EFFECTIVE DATE.

This Local Law would take effect immediately upon filing with the Secretary of State.
