**Camille and Dave Traver** have noticed that it is really dark for kids to be walking home from the high school from Poet's Landing to Lewis St., there are no street lights. Paul Sabin let her know that the NYS D.O.T. would have to be contacted to do a study as this is a state road. The subject of who pays for street lighting was brought up and the audience was told that the Village pays based on a flat rate unlike the meters on their homes. As for whether or not the cost has gone down since installing LED lights they were told it is too soon to give an accurate answer due to NYSEG estimated billing but that it has come down.

**Tim Woods** from118 Johnson Rd. Freeville works on the Town of Dryden Conservation Board wants the Board to consider allowing a deer culling hunt to help control the over population in the Village. Joe Guernsey who owns a corner property on Freeville Rd. has a perfect lot to set up a hunt. A feeder is set up to attract the deer then the hunters use crossbows at night with night vision to discard as many as possible. This is being done successfully in Trumansburg and Lansing and also on Cornell property. Professor Bernd Blossey has been organizing these hunts for them with DEC supervising.

He also would like the Board to consider having him back at a later meeting to explain and promote "Kiss the Ground". Controlling carbon dioxide in the atmosphere by pulling it out of the air and putting it back into the soil where it belongs. Tim handed out pamphlets on both proposals and the Board can visit the NOFA website to find out more.

#### **DEPARTMENT REPORTS:**

Public Works Report-Superintendent Paul Sabin- Gian Dodici from Federal Fish and Wildlife was asked to address the audience. He lives here and has worked with the Village for several years trying to lessen the flooding as much as possible. Flooding cannot be eliminated in the Village as we are in the 100 year flood plain. All we can do is try to lessen the impact from small rain events by allowing the water to move as much as possible as it should. Dredging the creeks does not work. Removing as much sediment and debris from rain events as possible does help. Retention ponds only work when they aren't already full from rain saturation so if they become full and it is still raining there will be flooding. Building berms just sends the problem downstream. It is possible that Springhouse Road is acting as a dry dam. There are two seven foot culverts that if larger might mitigate some of the flooding. Installing a series of larger culverts may help. Attenuating the flow by spreading it out can help. Warm season (native) grass attenuates more than lawn grasses do. Little things can be done to help with small rain events but won't stop flooding.

Dryden Police Dept. - Chief Tagliavento- The PD has had a busy month, the new recruit has written almost twice as many traffic tickets as usual. His report to the Board reflects that. The Public Safety meeting was held and there are no safety concerns at this time. The proposal for new cameras has come in much higher than expected so need to address that. The Board agreed.
