Caleb also let the Board know that while trimming a tree on Lee Rd., a branch got away from him and came down on a mail box. The mail box was destroyed. It had hand painting on it so the DPW has bought a new one and the Clerk treasurer has offered to paint on it for the home owner. He also wants the Board to be aware that there are several Ash trees that will need to come down because of the emerald ash borer.

Police Dept. – Sargeant DeCoursey reports that everything in the Police Department is running smoothly at this time. He handed out the monthly calls report. They did some DWI checks on St. Patrick's Day. The Chief and he attended Officer survival training March 6-8, and the full-time officers will be attending motorcycle awareness training soon.
