Mayor Murphy opened the Board Meeting at 7:03 p.m. The Pledge of Allegiance was recited.

Privilege of the Floor:

Privilege of the Floor was opened at 7:04.

Stephanie Mulinos introduced herself as the new Chairperson of the Dryden Café. She came before the Board to garner support for their continuing efforts to come back possibly at the old Rite Aid Building. There are three levels of support: Board Member, Coalition Member, or Supporter. They are still a 501C organization, need as much support as they can get. They met with The Town of Dryden a couple months previous and they would be willing to help with obtaining grants if they can. The Board unanimously agreed that the Village would do whatever they could to support the Café.

Mark Bell brought two options from Daryl Cross Excavation & Auger Service to repair the sewer lines from the house he owns at 4 Hillcrest Drive to the Village sewer main. The first option is a sewer line replacement of the existing line. There is no guarantee that this option will work due to the elevation of the house and the depth of the man hole being only 13 feet. Normally a sewer line needs to drop ¼" per every 10ft. in order to work properly. The existing line has less than 1/8" drop. The man hole may not be deep enough to obtain the proper ¼" drop every ten feet from the property. This option is \$11,550.00.

Option 2 would be to install a new sewer line down to W. Main St on a neighbor's property. Mark would be responsible for obtaining and easement. He is requesting that the Village of Dryden pay for the new pipe to be installed. The cost for option 2 is \$11,150.00

The Board inquired as to why option 2 was so expensive. It turns out the neighbor's property is rather wet even though it is a dry year. The Board decided that they needed to discuss this more and would notify Mark of their answer.

Privilege of the Floor was closed at 7:47pm

MONTHLY REPORTS:

Code Enforcement-Shelley Knickerbocker emailed her report and it was forwarded to the Board. Dave Sprout was in attendance. Two topics were discussed. 3 Logan's run has not had any further complaints regarding business deliveries at the residence. Bill Troy talked to several neighbors and confirmed this. 3 North St's Building permit has expired. A letter was sent to the owner's notifying them of this and that they needed to obtain an extension.

Camden Group- Ken Scherrieble says the sewer plant is running well. They had some Chlorine issues that have been taken care of. The rental pumps are gone, the system is running on pumps 1 and 3 while pump 2 is being cleaned and repaired. It was discovered that the control system that had been in place was set up to run 1 duty pump and then when needed either pump 2 would come on or pump 3 but never both pumps 2 and 3 at the same time. Changes have been made so they can decide which pump is the duty pump and that all three pumps can be run at the same time if needed.

The sludge pump was damaged and is being repaired. This is covered by insurance.

The old Sensaphone alarm system is now working and has been tested. A new Win911 system has been ordered that will allow text messages, and calls.

MRB Group- The lowest bid price received for completion of punch list GC Work Items for the Village of Dryden Public Water System was received by Boland's Excavating & Topsoil, Inc. MRB has contacted several references and are confident that Boland's will do quality work without excessive change orders. The Board may have seen Boland's trucks in the Village as they have been doing work for the Dryden Central School including water and sewer line extensions. He also thinks it would be a good idea to ask Boland's to give the Village an estimate to redo the restoration work at 248 Lake Rd. that the owner was not pleased with.

The smoke testing is still on schedule to begin on August 31, 2020 and will start on Lewis St. Trustee Wakeman has volunteered Trustee Fisher and himself to distribute the notices door to door.

The tank at Ferguson Rd. looks good and Lee Rd still needs topsoil. It is scheduled to be added in mid-September.

WHEREAS, it will be the job of the Section 3 Coordinator to prepare, implement and undertaken certain plans and procedures to facilitate compliance with Section 3 to the greatest extent feasible,

NOW, THEREFORE, BE IT RESOLVED that the Village Board of the Village of Dryden does hereby designate Debra

L. Marrotte and her successor, at such time she no longer serves in the capacity of Village Clerk, as the Section 3 Coordinator.

WHEREAS, the Village of Dryden is committed to the provision of equal access and equal housing opportunities for all its residents, and

DEPARTMENT REPORTS:

Dryden Police Dept. – Chief Tagliavento: The monthly incident report was handed out. The two new recruits have finished their 160 hours of training and are doing well. Chief Tagliavento met with Jason Crocker and Heidi Nydam who are two Dryden Central School students who are organizing a BLM march and rally. They wanted to march from the vacant parking lot next to the Dryden Queen Diner to Times Square. Chief Tagliavento explained that they would have to apply to the state for permits to march on and close off a state route. He also cautioned them regarding executive order Covid -19 rules.

He suggested a more visible route to residents might be Lewis St. which wouldn't impede traffic as much. They left knowing that they needed to contact the Mayor before setting anything up. Attorney Troy suggested that they would need to contact Tompkins County Health Dept. as well.

Chief Tagliavento also informed the Board that a man stepped out into traffic in front of Pizza and Bones and was struck by a car. His condition was unknown at this time.

Public Works Report-Supt. Paul Sabin: The drinking fountain should be installed at Montgomery Park as early as tomorrow but most likely next week. The crew was working on installing the netting to the rafters to keep birds from nesting and roosting. The Blue paint on the Pickleball Court is considered a warranty item and will be replaced.

ITEMS FOR BOARD DISCUSSION:

Mayor Murphy-brought LED street light samples for the Board to see. The most popular and the one most installed is a softer more orange kind of glow. The other option is whiter with a blue tinge. The Board was split on which they liked better. It was decided that they would get a better idea if the samples were on the poles in the parking light to see what they looked like in an outdoor environment.

Mark Bell's request for sewer repairs: The Board all agreed that option 2 was the better choice than option 1 because there is no guarantee that there is enough elevation to make option 1 work even if they replace the broken sagging pipe. After much discussion the Board decided to help pay for option 2 because the Village is responsible for the original sewer line repairs but the property owner will be liable for any sewer line issues or repairs from the house to the main hookup on West Main St.
